1. College Name Changes

Thomas Nelson Community College and Lord Fairfax Community College collected input from their communities and have decided to change their names. New names have not been determined. The State Board is responsible for all naming decisions and they meet next in July.

Patrick Henry Community college decided not to pursue a name change. They are located on the border of Patrick County and Henry County and therefore the name was determined to be locational.

2. ASAC Update on National Accreditation & Clinical Workload

Muriel Mickels is the CFAC representative from ASAC (Academic and Student Affairs Council). She reported that ASAC has formed a new workgroup on these agenda items which will report at the next ASAC meeting.

3. Tuition Waiver for Dependents

CFAC has created a subcommittee to draft a proposal to waive tuition for dependents of faculty members. There will most likely be a limit to the number of credits that could be waived and the courses would likely need to meet enrollment thresholds before dependents could register. This proposal would be submitted to the VCCS for review/action.

4. Discussion of a Potential VCCS-wide Group for Networking/Mentoring for Students of Color

Discussion of the various programs that currently exist at individual colleges. Muriel Mickles (ASAC representative) suggested that a conference for students of color could possibly be added to the existing student affairs conference.
