- Kickoff meeting with consultants from Gallagher Consulting last week (get specific date)

  - The initial RFP from HR did include compression
  - o This is a much more comprehensive study than TCC has had
  - The firm indicated that the various demographic factors for which data will be collected also include compression even though the specific term "compression" is not used

  - TCC grade and attendance reporting audits: TCC was cited for any instances for failing to report students who stopped attending. The argument that the onus should be on students is becoming moot at many schools because too many citations may result in Title IV ineligibility and at the very least a warning/probationary situation.
- Incomplete Grades

- Over half of the Incomplete grades that are submitted are missing the contract. This poses an issue if a faculty member does not continue employment among other reasons.
- Affects the contracts for FT and Adjunct faculty. The impact is of particular concern for adjunct faculty more because of the semester-to-semester contractual employment.

Update:	Points of discussion: Enrollment and factors contributing to current decline, the functionality of the website, concerns over testing centers no longer having Saturday hours, and potential goals for the semester. Goals centered around continuing concerns over areas impacted by structure, the bookstore, and adjunct retention.

Motions:	No motions at this time but the Norfolk Senate is working on a motion to address security concerns.
Update:	There was a discussion concerning safety on the Norfolk Campus. While there has been no significant incident on the campus the incidents that have occurred within the vicinity of campus has raised concerns among the faculty. It was noted that the level of security used for access to the Green District Administration Building is not used for the remainder of the campus leaving some faculty to wonder if the lives of the students, faculty and staff on the campus are less of a concern than those working in the district building. The following items are being worked into a motion that will come from the Norfolk Senate to campus and college leadership:  • Reactivation of the card readers in the front of the buildings. • Return of the security desk to near the front door of the Walker Building from the

- middle of the building. An intruder can easily access classrooms, offices and the second floor before reaching the security desk.
- The creation of a security task force specific to the Norfolk Campus that has significant faculty representation.
- Reactivation of the doors to the Roper and Martin building badge use to enter the building - these are the only two buildings on campus that have that capability. At the moment the system is only utilized from 7 pm to 7 am.
- Installation of panic buttons that work similarly to fire alarms expect these would be used for an intruder/active shooter.

Additionally, there have been issues with the technology in room 2404 for hyflex classes (this room is set-up to be hyflex). Students have become angry that they can't access the class.
