## Faculty Professional Development Committee MINUTES

March 14, 2023 Zoom 2:00 – 4:00 p.m.

- I. Call to order by Renee Hosang-Alleyne @ 2:02 p.m.
- II. Approval of Minutes from February 2023 is unanimous without amendments.
- III. Chair's report (Renee Hosang-Alleyne)
  - a. The PAPC met briefly in February but will have another meeting at the end of March. Chair Sarah DiCalogero said that FPDC by-laws can be discussed at that meeting. There was a review of various committee charges and about half of the committees were in attendance. Dr. Woodhouse addressed the committee and noted how the administration values faculty input. The Distance Learning and Technology Committee encouraged faculty to submit Helpdesk tickets for screens mounted incorrectly in classrooms (taking up a significant part of the white board).

  - d. Purpose II.F is deleted since the partnership with the Center for Teaching Excellence addresses any statewide collaborative efforts.
  - e. Add II.F "Partner with the Center for Teaching Excellence in realizing its vision by providing guidance through sustained dialogue and active assistance in implementation of initiatives and programs."
  - f. Add II.G "Collaborate as necessary with other college-wide stakeholders involved in professional development, including but not limited to the DEI council; TCC libraries and tutoring; Distance Learning; and the Faculty Senate Professional Development Committee."
  - g. The committee discusses the composition of its membership.
  - h. III.A has "elected by college-wide by peer group" edited to "elected by peer group in case of multiple candidates."
  - i. III. A has "A Counselor and Librarian will be elected college-wide by their peers" edited to "A Counselor or full-time Student Affairs staff member will be elected by their peer group in case of multiple candidates. A Librarian will be elected by their peer group in case of multiple candidates."

- 1. VI. B. 2 will be updated to remove "using the template provided by the PAPC."
- m. VII. A. is updated to reflect that the committee meets virtually: "Meetings will be held synchronously online with an in-person option available as needed."
- n. The committee will have a Google Form created so that committee members have a few days post meeting to review the by-laws prior to their approval.
