V. Open Business

A. Policy 2105: Role of General Education Committee

- A motion was made and seconded regarding amendments to the language defining the role of the General Education Committee in Academic Policy 2105. Proposed language was as follows:
 - o 4.7 -- Role of General Education Committee
 - 4.7.1 -- The General Education Committee will consider courses for inclusion as general education and approved transfer elective courses and will perform periodic reviews of these courses to ensure they are continuing to satisfy required core competencies and transfer suitability.
 - 4.7.2 -- The General Education Committee will review and recommend any revisions to policies, plans, or other relevant documents that are germane to the purpose of the General Education Committee.

B. Statement about the General Education Committee

- David Kiracofe mentioned that the General Education Committee should draft a statement to address its purpose and connections to the curriculum, competencies, and assessment.
- Committee members brainstormed ideas for this statement and mentioned that General Education criteria could be added to our Governance website.
 - Verbiage for this statement could be taken from Policy 2105 and state "These are the criteria the General Education Committee uses to consider courses for inclusion as general education or review approved transfer elective courses."

C. Pathways/Default Curriculums

- The Committee agreed that the role of the General Education Committee in relation to Pathways will be better guided after the default curriculums are determined on May 15th.
- Jennifer Ferguson mentioned that the Committee may want to brand itself the way
 that the Instruction Committee has. This may be as easy as asking Visual
 Communications to create a Unit Logo and email template for the Committee.
 Another idea was to create a fact sheet listing the Committee's role in Guided
 Pathways.

D. General Education Assessor Training

- Assessor Training took place on Friday, February 16th from 1-4:30 in Green 507. Laura Soulsby and Heather Fitzgerald facilitated this training.
