- The Committee agreed that in order to encompass the specific work that TCC participates in, language should be added to include the new competencies of Professional Readiness and Civic Engagement as well as mention of Guided Pathways.

- The Committee looked at the General Education Assessment discipline-specific results and discussed how this information could be used to address this charge.
- Jennifer Ferguson mentioned that there is a TCC draft of the GEA Plan Framework and she will bring the draft to the January meeting.

B. General Education Course Vetting for Social Science Electives

- David Kiracofe led a discussion on a course vetting process for social science electives.
- 10 Social Sciences electives are due for review in the Spring of 2019.
- Committee members suggested that the Pathway Deans should be contacted to create a schedule of opportunities for faculty to review courses and present to the GEC in the Spring of 2019.
