- I. **Call to Order by** Chair Jim Roberts at **12:30 PM**
- II. **Guest Speaker:** The chair introduced Dr. Stemple for a brief presentation on the efforts of the Professional Development team. He emphasized the new location of the Virginia Beach campus Batten Center, encouraging everybody to visit it and check out the capabilities. He touched on the upcoming discipline meetings covering the scheduling process in development.
- III. **Introduction of Senators:** The Chair asked that all in attendance introduced themselves.
- IV. **Review/Approval of February 25, 2016 Minutes** Approved 12:42 PM.  
**Review/Approval of March 31, 2016 Minutes** Approved 12:44 PM.
- V. **Chair's Report:**
  - A. In compliance with state and federal regulations, the VCCS will be implementing software system-wide to identify courses outside of approved degree programs, which are ineligible for financial aid.
- VI. **Old Business:**
  - A. The Executive Committee meeting discussed the convocation AND the Annual College Picnic, as there were many complaints from the previous year's events. It has been decided that these will be two separate events with complete details to be disseminated at a later date, with the convocation to be at the Chesapeake campus, and the picnic at the Work Force Campus in Suffolk.
  - B. The enrollment for the upcoming semester has the online degrees enrollment at the Virginia Beach Campus down by 1.2%, where the face-to-face is much higher (no figure given).
  - C. There are new workbooks out for the student orientation.
  - D. President Kolovani worked a few shifts at the College Center. She observed the need for a new training program for this office, and she noticed a lack of standardization between the four campuses.

- E. The International Business exchange with Denmark is approaching. This year is extending to a three week evolution. In previous years, it was primarily at the Portsmouth campus, this year will involve Portsmouth and Virginia Beach, with the Norfolk campus being introduced to it.
- F. **Technology Support:** Faculty are encouraged to seek presentation station training from Learning Technologies (LT). VB campus lead tech Tung Trinh (OIS) says there are constant changes being made to the podiums, and suggests training/retraining to avert problems in the classroom. Although OIS staff are responsible for the network and what runs on it, they will help “on the spot” with classroom problems. LT staff are responsible for the operation of the presentation stations, and there is a full-time LT staffer (Kyle Smith) and part-time (Marcus Resnick) dedicated to the VB campus. *Helpdesk tip for urgent situations: specify if tech may enter your class while in session.*
- G. **Course Scheduling:** Proposed policy for pilot project that will invite faculty to have a role in the course scheduling process will be made public soon. Faculty may organize college-wide to make recommendations on course offerings within their respective disciplines. This is a faculty driven evolution, with it proposed that faculty attend the May 3<sup>rd</sup> dialogue with Dr. DeMarte .
- H. **“Bumping”** is addressed in the pilot project policy proposal: “If bumping for a class assignment is necessary, each request shall be reviewed and approved by the appropriate Dean/Director, and the effect on students, faculty, and the program shall be minimized.” *Q: How shall inter-campus bumping work?*

- C. **Faculty professional development funding for adjuncts** restricts funding to professional development events during semester that adjunct work. For example, the Virginia Master Teacher Seminar takes place during the summer semester June 26-30, 2016. “I am not scheduled to teach a course during the summer and consider this to be the most opportune time to participate in professional development opportunities. Thank you for your consideration.” [Vera Holmes]. The adjunct have historically been denied this option as they DO NOT have a contract with the College, therefore state funds cannot be used. It was asked if this could somehow be granted out of some TCC endowment type funds.
